ORDER:

In the G.O.1st read above, sanction of the Lieutenant Governor was accorded for grant of financial assistance to 27 SC indigent artistes and the dependent spouse of the deceased indigent artistes (26- Puducherry to 1- Karaikal) distinguished in performing visual arts for the months from of April 2016 to October 2016. Out of the above mentioned 27 Indigent artistes 1 SC Indigent Artist were found expired/receiving other pension and hence 26 SC Indigent artistes/ dependent spouse of the deceased indigent artists exist in Puducherry and Karaikal regions.

2. Accordingly sanction of the Lieutenant Governor is accorded for Rs.3,19,750/- (Rupees Three lakhs ninety thousand seven hundred and fifty only) towards payment of financial assistance to 25 SC Indigent Artistes for Puducherry region and to 1 SC Indigent Artistes for Karaikal region for the period from November 2016 to March 2017 (5 months) as detailed in the Annexure to this G.O. as follows:

Sanction of the Lieutenant Governor is also accorded to draw the amount in advance on every month as per requirement from the amount Rs.3,19,750/- (Rupees Three lakhs ninety thousand seven hundred and fifty only) sanctioned in para 2 above in advance by the D.D.O., Directorate of Art & Culture, Puducherry for payment to the beneficiaries through bank under ECS for every month subject to rendering of accounts to the DAT as per rules.

4. The expenditure is debit to the Head of Account in the Budget of the current financial year.
